*[Floornature \(www.floornature.com\)](http://www.floornature.com), the architecture and design portal published by [IRIS CERAMICA GROUP](#), promotes the ninth international contest for architects and designers. The 2020 contest is entitled “**AN EDUCATIONAL GARDEN IN FIORANO MODENESE**”.*

[Definition and Theme of the Contest](#)

The contest is in the form of an anonymous “Ideas Contest” with open procedure (under Art. 156 of Legislative Decree No. 50/2016). It is aimed primarily at recent graduates and young professionals in the fields of design, architecture, urban design and landscaping.

By means of the most effective and appropriate methods, participants should submit a design proposal in respect of new outdoor areas for “**Casa Coccapani**” nursery school in Fiorano Modenese (MO).

[Aims and Objectives](#)

The redesign of external areas adjacent to “**Casa Coccapani**” nursery school to complete the restoration and seismic upgrading works recently carried out on the building. The ideas contest will provide us with innovative solutions to rethink areas used for the little ones’ outdoor activities and construct a real “**EDUCATIONAL GARDEN**”. The project should not only introduce innovative aspects relating to designing areas for growth and learning, but also create a new, more integrated relationship between the individual, community and green space. The project has the ambitious objective of guiding children from a young age in a way that promotes awareness of the importance of individual and collective actions in the care and conservation of all living creatures.

[Vision and Principles](#)

Designing spaces for growth and learning is an act of social responsibility. When we devise and put forward design solutions for places where future generations will be educated, we must be aware of laying the foundations for the development of individuals and the community. The quality of the area is fundamental to a child’s growth from their formative years since the message a child receives from the physical environment

influences their social and cognitive behavior. Children have a much more intense sentimental and emotional attachment to a space than adults, because they experience it with their entire body and attribute value to it through odors, sounds and visual stimuli.

William Glasser (Control Theory in the Classroom, 1986) states that 80% of what you learn is through personal experience, while only 20% through listening. In education there is also a need to put in place various measures which help to develop critical thinking and the ability to learn to interact with others.

Other aspects essential to the design of innovative educational areas relate to the principles of co-operation, inclusion and diversity.(Hack the School). Inclusion in the classroom is also promoted within the framework of Sustainable Development Goals, where a whole-life approach for students (lifelong learning) is promoted, above all supporting wider community engagement.

The principles which guide the design of learning spaces go hand in hand with those of urban regeneration. Re-imagining under-used, run-down or disused spaces in our cities, via sustainable design solutions based on the needs of the environment, has a direct impact on the residents' lives and their sense of belonging. When the school space becomes a de facto "community space", its redevelopment ultimately leads to social cohesion.

Program and Guidelines

The exterior courtyard at "Casa Coccapani" nursery school shows visible shortcomings in terms of quality, comfort, reduced accessibility and inadequate use of green space. The most problematic aspect is the separation between external areas and the inside rooms of the building, exacerbated by a driveway which divides the courtyard in two. In addition, the children's garden covers less than half the total space available. The new play space should be an ecosystem that provides its young users with countless opportunities to learn by experimenting, exploring, and discovering the surrounding world in a comfortable and safe environment. This new "educational landscape" project should ensure the following qualities and properties:

- *Beauty and simplicity*
- *Physical and mental well-being*
- *Inclusion and accessibility*
- *Sharing, acceptance and diversity*
- *Flexibility and adaptability*
- *Cost-effectiveness*

The quality of the spaces directly depends on architectural aspects, such as shape, organization and overall effect in relation to light, colors, sounds, and tactile sensations.

While providing unimpeded vehicular access to the courtyard for emergency vehicles only, the functional layout should include the following types of spaces:

- **COMMUNITY ZONE:** Plaza/Agora, an area free of obstacles for the free movement of users
- **OUTDOOR ZONE:** A small garden, an area for exploring nature including various types of plants suitable for little ones

Other areas may also be included/integrated such as, for example:

- **DISCOVERY ZONE:** Educational garden, a workshop where they can experience nature
- **ACTIVE BREAKOUT ZONE:** Play area/gym, an area equipped for fun and movement
- **DISPLAY ZONE:** Small theater, to organize outdoor performances
- **QUIET ZONE:** Relaxation area, to sit and interact with others
- **PROJECT ZONE:** Outdoor teaching area
- **ACTIVE STORE:** Space to take out and store teaching and recreational materials

Specific Requirements for the Area

The proposal must provide solutions which do not involve substantial changes to the layout of vehicular access or removal of existing vegetation.

Particular attention must be paid to the quality of the surfaces for the project by reassessing the materials and appearance of current finishes, whether floor coverings, paving or vertical surfaces. Designs which propose less invasive work are preferred, with demolition and structural modifications limited as much as possible. Participants are encouraged to assess the relationship between space and activity, to offer flexible, multi-purpose design configurations which stimulate the children's curiosity and sensations. Designers are encouraged to take into account the predetermined budget available to implement the proposed works, which should not exceed **40,000 Euros**

Recommendations for products intended for games, and fixed and/or mobile furnishings to complete the project should be considered as an additional cost to the budget indicated.

Information Documentation

Detailed site inspection, photographic and video documentation in respect of the project area can be downloaded inside your personal area.

Criteria for Evaluating the Proposals

Based on the program outlined above, priority will be given to those designs which fully satisfy the required function and which provide not only spatiality but also a cohesive, pleasant and well-balanced design compatible with the project.

Proposals will be evaluated in line with the following criteria:

- a. Originality of the design
- b. Relationship between children and space
- c. Functional, aesthetic and conceptual innovation
- d. Technical and economic feasibility

Documentation Required

Entry drawings are required as follows:

- 3 submission drawings containing plans, sections and elevations of your choice in jpeg format, 1280 x 1024 pixels 300 dpi image resolution
- 3 images of your choice as deemed necessary to best describe the proposal (rendered images, photographs of models, sketches, schedules, etc.) in jpeg format 1280 x 1024 pixels 72 dpi image resolution.
- Project summary in English (maximum 1800 characters)

Participation and Registration

The contest is open to all young creative designers from architecture and design disciplines who graduated from 2010 to the present day. Only individuals may take part.

Receipt of Entries

In order to ensure equal opportunities and for the purpose of subsequent publication, participants must comply with the following when submitting entries.

Participation in the contest is anonymous.

To ensure anonymity, an alphanumeric code identifying the project will be assigned by the system when completing the registration form.

All materials must be uploaded by clicking on upload in the reserved area on the following link <http://www.floornature.com/nextlandmark/subscribe> accessed following registration. Once accredited, the requested materials can be uploaded anonymously.

All files in the format requested will automatically be renamed by the system, with a code assigned in order to ensure anonymity in respect of the jury.

Once uploaded, no further changes may be made to the entry.

All entries must be uploaded by **May 30, 2020**

All entries in accordance with the guidelines referred to in this document will not be returned.

The jury will publish a final report outlining the evaluation criteria and motivation in respect of the winning entry.

- The Jury may also exclude, at their discretion, those whose conduct is not consistent with fair competition.
